Coronavirus (Covid-19) continues to dominate headlines with news of its spread and potential new cases in the United States and New York. While we are uncertain of how this outbreak will affect the operations of Sri Ranganatha Temple, Board of Trustees shall make a decision, as we get closer to AGM, and inform you in case we need to postpone or cancel AGM meeting and elections. Please refer to our website (www.ranganatha.org) as we get closer to AGM.

Five trustees will be elected during 2021 elections. The vacancies are as follows. Two trustee positions for threeyear term, One trustee position for two-year term and two trustee positions for one-year position. For eligibility requirements, please see the enclosed information on "Who is eligible to contest as a trustee".

All completed nominations along with the required documentation must be post marked on or prior to May 1, 2021. Any nomination received bearing a post mark after May 1, 2021 will be rejected. ALL NOMINATIONS MUST BE RECEIVED BY MAY 7, 2021. It is your responsibility to make sure that your nomination is received by the deadline.

All eligible nominees are requested to attend (not mandatory) a meeting at the temple on Sunday, May 21, 2021 at 2 PM to find out if there are any deficiencies with their nomination forms or why the board rejected your nomination. Please take good care in filling out the nomination forms correctly to be eligible to contest in the elections. The photograph and Nominee statement will be posted on the Temple website and/or bulletin board for the benefit of the voting members. This is the only way you can appeal to the prospective voters and you will not get any other opportunity to address the members at the AGM before election. We strongly recommend that you send the Nominee statement and if we receive no statement, then you will not get to inform the members why they should elect you as a trustee.
